VEHICULAR AND PEDESTRIAN TRAFFIC ON SCHOOL PROPERTY

No person shall drive any motor vehicle or operate any snowmobile or similar machine or ride on any land owned or which forms part of a school site administered by the Board of Education for School District No. 87 (Stikine). The only exceptions are those identified in the accompanying regulations.

1. Exceptions

- 1.1 **Delivering** – Person proceeding to or from school buildings on roadways provided for that purpose in the course of delivering or receiving chattels in connection with the operating part of the school.
- 1.2 **Board Employees** – Persons proceeding to or from school buildings on roadways provided for that purpose in connection with their duties therein, or on other bona fide business with the operation of said school buildings.
- 1.3 **Students** – Persons proceeding to or from school buildings on roadways provided for that purpose who are students registered by that school.
- 1.4 **Consent of Board** – Persons who have received permission, either expressed or implied, from the Board of Education.

2. Speed Limit

- 2.1 No person shall operate any motor vehicle or operate any snowmobile or similar machine on any land owned or administered by the Board of Education for School District No.87 (Stikine) or which forms part of a school site, at a greater rate of speed than 10 km/hour unless otherwise posted.

3. Parking

- 3.1 No person shall park or otherwise leave unattended a motor vehicle, snowmobile or similar machine, upon land which forms part of a school site, in other than recognized parking areas set aside for this purpose by the Board of Education unless given expressed permission to do so.

4. Trespassing

4.1 No person shall trespass or loiter upon any land owned or administered by the Board of Education for School District No.87 (Stikine).

5. Registered Owner Responsibility

5.1 The owner of a motor vehicle or any snowmobile or similar machine, shall be held responsible for any violation of the Policy by a person entrusted by the owner with the possession of the motor vehicle in respect of any offence within the scope of this section, and the burden of proving that the person so in possession of the motor vehicle was not a person entrusted by the owner with the possession of that vehicle, shall be on the accused.

5.2 Everyone who, without the permission of the Board of Education for School District No.87 (Stikine), is the owner or person in charge of an animal upon land owned or administered by the Board of Education for School District No.87 (Stikine) commits a breach of this Policy.

6. Complement to Other Statute or Policy

6.1 The provisions of this Policy are not intended to restrict the enforcement of the *School Act*, the *Motor Vehicle Act* or regulations pursuant thereto, or other such Policy.

7. Breach of Policy

7.1 Except as is otherwise provided in this Policy, any person contravening or committing any breach of, or committing any offence against any of the provisions of this Policy or who suffers or permits any act or thing to be done in contravention or in violation of any of the provisions of this Policy, or refuses, omits or neglects to fulfil, observe, carry out or perform any duty, obligation, matter or thing whatsoever by this Policy prescribed or imposed or required to be done is guilty of an offence.

8. Authority to Make Regulations

- 8.1 The Board of Education may by regulation erect traffic control devices to regulate, prohibit control and direct vehicular and pedestrian traffic on land owned or administered by the Board of Education for School District No.87 (Stikine) or which forms any part of a school site. The erection of such traffic control device shall be deemed as prima facia evidence that such device was erected at the direction of the Board of Education.
